CALLING EXPRESSION OF INTEREST (EOI) TO DESIGN, BUILD, FINANCE AND OPERATE A FUEL STATION & A FACILITY HUB AT KERAWALAPITIYA

1. Introduction

Sri Lanka Land Development Corporation (SLLDC) intends to establish a fuel station and a facility hub at Kerawalapitiya.

It is designed to meet the growing demand for modern, sustainable, and customer-centric fueling solutions in the region while simultaneously providing a multifunctional space in the said establishment.

Accordingly SLLDC invites Expression of Interest (EOI) from eligible entities to Design, Build, Finance and Operate a fuel station & facility hub at Kerawalapitiya.

2. Scope of the Project

The Project shall include the following;

- 1. Fuel station
- 2. Facility hub including supermarkets, restaurants

The selected proposer (Private Party) shall Design, Build, Finance and Operate the said Project for 30 years.

SLLDC shall provide a land of 0.6533Ha (approx. 1.61 Acres) in extent at Keralawalapitiya in order to execute the said Project.

A suitable mechanism shall be formed between SLLDC and the Proposer selected through EOI and followed by Request For Proposals (RFP) process.

The revenue earned from the said project shall be shared between SLLDC and the proposer selected by the RFP process.

4. Eligibility Criteria

4.1. A Proposer shall be a private entity or government-owned enterprise or any combination of them with a formal intent to enter into an agreement.

- 4.2. The following information shall be provided by the Proposers in the EOI:
 - (a) A comprehensive corporate profile of the party responding to this EOI including the registration of Business, (Refer to the *Annexure I: Corporate Profile*);
 - (b) Experience in investing and operations in similar projects (such projects shall mandatorily include operating a fuel station);
 - (c) Historical Finance Performance Audited financial statements for the last 5 (Five) years (from 2019 to 2023)
- 4.3. The party expressing interest in this project shall have the legal capacity to enter into an Agreement with SLLDC on all terms and conditions that are required to be agreed upon.
- 4.4. Only those proponents who have been short-listed based on this EOI submitted shall be invited to respond to the Request for Proposal (RFP).
- 5. A Pre-discussion prior submission of EOI shall be held on 14th May 2024, at 10.00 hrs at the Conference Room of Sri Lanka Land Development Corporation with participation of Investors/representatives of the Investors.
- 6. The EOI and all other relevant documents shall be submitted as one original hard copy. The sealed envelope carrying EOI and other relevant documents shall be labeled "Calling Expression of Interest (EOI) to Design, Build, Finance and Operate a Fuel Station & a Facility Hub at Kerawalapitiya" on the top left-hand corner of the envelope.




